31.74 ***Minutes of Last Meeting***

In addition at 31.66 Cllr Dixon confirmed it should read notification of the date of commencement and Cllr Alder requested an amendment to 31.67 to replace wording with conclusion highlighting the main points.

31.75 ***To discuss and agree the response to the Braintree District Council Local Plan Review***

Following the recent call for sites input is being sought from Braintree District Council (BDC) on the local plan review. There are no sites within the Parish.

The members of the public took an active interest in this part of the meeting and a discussion was made about the possibility of extending the village envelope and the policies in place for planning/development. The current plan was reviewed.

It was agreed that a response would be made to confirm the Council seek to protect the green spaces within the community and that the BDC policy for not permitting infill sites or ribbon development extensions is supported.

It was agreed the response would request BDC to consider the Terling Village Design Statement as supplemental planning guidance in the next local plan as this was prepared via a large community effort.
